- **Substitute Paraeducator - \$17.35 Per Hour**

Cultivating life-long learners and helping our students succeed is The Viking Way. Substitute Paraeducators must meet the following requirements in order to be approved to sub:

- * Be 18 years of age or older.
- * Have a High School Diploma or its equivalent.
- * One of the following
 - a. An AA degree or higher
 - b. 72 college credits or 48 semester credits (Must be post 100 level courses)
 - c. Have passed the ETS Para-Pro Assessment
 - d. Paraeducator Portfolio Assessment approved by OSPI
 - e. Washington State Apprenticeship

- **Certificated Substitute - \$150 Per Day/\$75.00 Half Day**
